CLUB BOOST - A TOOL YOU CAN USE!

How many of you have heard of a Club Boost? I hadn't until I was a Lt. Gov. and then it sounded like an a wfully lot of work because, as you can see from the attachment (SEE NEXT PAGE), it's got a lot of moving parts! And an organizational requirement that looks like a military operation!

The truth is that I actually participated in one not too very long ago that four of us were able to effectively pull off in one day! Also, I was always under the assumption that a Club Boost was akin to 'Last Rites', it's what you did in trying to stave off surrendering your Club Charter. Not True! Not True At All!

The truth is EVERY CLUB, that's correct, EVERY CLUB ought to use this tool!

So, here are some effective and relatively simple Club Boost rules to follow:

- 1. Create a small committee consisting of your Membership Chair and one or two others
- 2. Start pulling together a list of from 30 to 60 - depending on how big your team is - folks in

- your community you'd like to see become members of your Kiwanis Club
- 3. Focus on and select a date
- 4. Contact you Lt. Governor on what you'd like to do!
- The Lt. Governors will get the partnering team members to go with you and your team members, and make the actual contact calls on the day that you and your team have set up appointments for.
- And this is the most important step: You've GOT to set up solid appointments!
- 7. Your teams make the sales call, armed with an application and ask for a check on the spot!

There are a lot of former District Governors, and others, located all around our beautiful state that are just eager to help with this sort of effort.

INTERCLUB UPDATES

Interclubs are visits to other Kiwanis Club meetings or events, visits to SLP meetings or events, and attendance at Kiwanis training conferences and Kiwanis conventions. Interclub visits are fun and informative and can lead to enduring friendships. They also give you an opportunity to see what other clubs are doing, allowing you to adopt those activities that can benefit your club. It also assists clubs in learning how to conduct business the "Kiwanis Way."

An interclub must have at least two members from a Club to count as an "official" interclub visit. I noticed in the 2022-2023 end-of-the-year Interclub Summary Report that 80 clubs did 989 interclub visits last year. Those clubs who do a very good job of interclubbing are presented with a special patch for their club banner. The criteria for completing the Interclub Challenge for a banner patch is to have at least eight interclubs to other Kiwanis Clubs. SLPs. Training Conferences, and Conventions do not count for the Interclub Challenge, but do count as interclubs. Last year 33 clubs earned an interclub patch. Some clubs do not stop at the minimum, so we give special top-10 patches to the clubs with the most visits and also top-10 patches to those who have traveled the most miles. Last year the club with the most visits had over 80 interclubs and the club traveling the most miles had almost 10,000

one-way miles traveled. This is one advantage of a club nominating a Kiwanian for district office and another advantage of attending the KI International Convention. It's a long way to Colorado!

Setting up an interclub is easy. Start by finding someone in your club who also wants to do an interclub and talk to your Club President, Secretary, or Interclub Chair. Go to the District Directory at http://www.georgiakiwanis.com/ga-district-directory.html to find information about when and where other Kiwanis clubs meet. Find the club you want to visit. You get the contact information about their President and Secretary and the day, time, and location of their meeting from the directory. To schedule an interclub with another Kiwanis club, contact their President, Secretary, or Interclub Chair to make sure they are meeting the time you wish to attend. In some clubs, the President, Secretary, or Interclub Chair will make contact with the club you wish to visit. Follow your club's procedure. When you get back, be sure to tell your President and Secretary.

The Secretary is responsible for reporting all interclubs on your club's monthly reports and to me to assure you have credit for completing the interclub visits. I should be notified also in addition to entering the visits on the Secretary Dashboard. A number of Secretaries also let me know when they have completed the Interclub Challenge. Keep up the good work!

CLUB LEADERSHIP EDUCATION (CLE)

Just a reminder that it is never too late to educate your club membership. We are fortunate in the Georgia District of Kiwanis to have several qualified instructors who are more than willing to conduct a Club Leadership Education in your division. If your club is interested, I ask that you reach out to your Lt. Governor so that a training session can be coordinated.

There is an online Club Leadership Education available on the Kiwanis International website. Although this training session is not specific to the Georgia District, it does offer good information for club officers. It is noted that this Kiwanis International version does not count for the criteria for a Distinguished Club in the Georgia District. Even though it does not count towards being distinguished, this training can still be very beneficial.

The Auditory-Verbal Center (AVC), a nonprofit organization 501(c) (3), provides a family-centered and holistic approach to supporting and improving the lives of the deaf and hard of hearing. AVC provides Auditory-Verbal Therapy which teaches children with all degrees of hearing loss how to listen and speak WITHOUT the use of sign language or lip reading. AVC has locations in Atlanta and Macon, and for those families who can't make the drive, they offer Teletherapy. All funds raised through this "Buck-n-Ear" program helps pay for Auditory-Verbal Therapy sessions for families who are underinsured or can't afford the services. GEORGIA DISTRICT ART & MUSIC SHOWCASE

For over 30 years, the Georgia District of Kiwanis Art & Music Showcase has provided students with the opportunity to demonstrate their talents in a competitive atmosphere with students from across the state. The students have received certificates, trophies, awards, and scholarships in recognition of their talent and efforts. In order to qualify for the District Competition, the student must be a winner of a local showcase and sponsored by a Kiwanis Club within Georgia during the same Kiwanis year, and also meet the qualifications for the local and District competitions. In 2017, the Georgia District Kiwanis Foundation provided a total of \$15,000 in Educational Scholarships (\$7,500 for the Art Contest and \$7,500 for the Music Contest). The first-place winner in each contest received an educational scholarship of \$3,500 each.

Step 2: Select book drive dates and where books will be collected and get approval. Find dates that don't conflict with other events. Pick places to put collection boxes. Get approval from your principal or administrator.

Step 3: Complete key planning tasks. Gether supplies, create and hang posters, decorate: and set up collection boxes.

Step 4: Laurch the book drive and check on progress! Watch donation boxes so they don't. overflow.

Step 5: Sort and box books at the end of the drive. Set aside books that are not the type the ontanization needs.

Step 6: Donate the collected books. Arrange to drop the books off at the organization or for their staff to pick them up.

EVERY CLUB SHOULD CONSIDER OPTIONAL CRIME AND/OR ACCIDENT COVERAGE

Kiwanis International provides general liability as well as directors and officers liability insurance. However, your club's options for financial coverage don't end there. Kiwanis offers optional crime and accident insurance coverage programs.

Participation in the crime coverage program is the only way to insure your club against criminal theft. Every year, many Kiwanis clubs lose money to such theft. Since clubs vary in size, activities and assets, each club can choose which limit is appropriate: US\$10,000, \$25,000 or \$50,000. Some clubs have even been tricked into sending money to a fraudulent third party. With the crime coverage program, \$5,000 of coverage is also included for these kinds of events.

With the Kiwanis Accident/Medical program, your club will have accident insurance that helps pay medical expenses for injured Kiwanians and volunteers. Here is an accident insurance claim example -The Kiwanis club runs a weekly bingo game as a fundraiser, and the sponsored Key Club runs the concession stands. As one of the Key Clubbers is returning from the storage area carrying supplies, she trips over a wayward box (which she left there) and falls forward, hitting her head on the floor. The


ambulance is called, and she is rushed to the hospital. She has a concussion and a cracked cheekbone. Her family does not have health coverage. The covered accident insurance may apply.

To approve the club's purchase of either or both options, submit the purchase to your club's board in time for them to review, approve and send the application and payment by the deadline.

These coverages will be available next year between August and October 2024.

YOUTH PROTECTION

The year has begun. Kids are in school. K-Kida, Builders Clubs, and Key Clubs are in full tilt. Are we doing what we need to do in order to keep them safe?

Do each of your SLPs have an assigned Kiwanis Advisor? (I know that some don't. I think that is a poor way to sponsor an SLP).

Does each Kiwanis Advisor have an approved Kiwanis Background Check? (I know there are some that do not. That is completely unacceptable and leaves your club at great risk. This needs an immediate remedy.)

Do all of your approved chaperones have an approved Kiwanis Background Check? You need to know that they do. Again, the liability is yours if you do not ensure your youth are protected.

For your advisors and chaperones: have they completed the required Praesidium Abuse Prevention courses? These must be repeated every two years.

Has your club completed its mandatory annual club training on Youth Protection Policies and Procedures? (Some have, some have not. Please make sure you get it done as soon as possible. Failure to do so puts our insurance rates at risk.)

If you have completed your club training, has your secretary indicated so in the monthly report? If not, how would anyone outside your club know it was done?

If you are unsure about any of these questions, now is the time to get your questions answered. Reach out to me and let's make sure you and your youth are protected the best we can do.

YOUTH PROTECTION POLICIES & PROCEDURES UPDATED OCTOBER 2022

These policies can be found in Kiwanis International Policies and Procedures as **Procedure 432.**All adults working with youth under the age of 18 at any Kiwanis event are required to read/understand, agree to and abide by these policies.

EDUCATION: Every Kiwanis club is expected to inform and educate its members on these policies, best practices and required actions for individuals who become aware of youth in potentially harmful situations. This education must occur annually, including providing a copy of these policies to each club member. Every Kiwanis district is expected to provide an educational forum or workshop at every district-produced convention and conference regarding policies and best practices for adults working with youth, using materials provided by Kiwanis International.

CRIMINAL HISTORY BACKGROUND CHECKS: Kiwanis

International requires clubs to have a clear criminal history background check for any club member serving as an advisor to any Service Leadership Programs club. The check must be conducted and verified by Kiwanis International. Any person without a clear criminal history background check may not serve as the advisor. Approved background checks shall be valid for no more than two years. Kiwanis advisors shall acquire a new criminal history background check upon their initial appointment to the position.

CHAPERONE: A chaperone is defined as a Kiwanis member, faculty member, parent, legal guardian or person who is in loco parentis, twenty-one (21) years of age or older, who has been approved by the school or agency and registered with the school or agency to accompany the youth members at the specific event. All chaperones (club members and non-members) participating in any single-day or overnight Service Leadership Programs event must have a clear criminal history background check and must have completed Kiwanis International youth protection training. Additionally, chaperones must follow all applicable policies and procedures.

CHAPERONES FOR OVERNIGHT EVENTS: A minimum of one adult per 10 students must be serving as chaperones during the entirety of an overnight event.

CHAPERONES FOR SINGLE-DAY EVENTS: A minimum of one adult per 50 students must be serving as chaperones during the entirety of a single-day event.

OVERNIGHT EVENTS: All adults (club members and non-members) registered for or staying overnight at any Service Leadership Programs event must have a clear criminal history background check and must have completed Kiwanis International annual youth protection training. However, parents/guardians of participating students who are not chaperones may attend the event for a maximum of one overnight stay without a criminal history background check.

OVERNIGHT STAYS: While attending a Kiwanis event that requires an overnight stay in a hotel or camp/ conference setting, adequate adult chaperoning is expected and must include no fewer than one adult male for each ten or part of ten youth males, and one adult female for each ten or part of ten youth females. Except for a parent sharing a sleeping room or other sleeping quarters (e.g., a tent) with his/her own child, no adult should share a hotel or dormitory sleeping room or other sleeping quarters with a youth. In the event that sleeping quarters consist of multiple beds (such as in a bunkhouse or camp cabin), adults may share the sleeping quarters with youth members of the same gender, provided that two or more adults are present.

DISTRICT ADMINISTRATORS FOR SERVICE

LEADERSHIP PROGRAMS: Kiwanis International requires all SLP district administrators to complete an application process, which includes submission of a completed application, having a clear background check conducted and verified by Kiwanis International, completion of Kiwanis International youth protection training and any other elements that may be required by Kiwanis International. After receipt of an individual's application and verification of all required elements, Kiwanis International will review the information and decide, in



its sole and absolute discretion, whether the individual is accepted to become an SLP district administrator. Kiwanis has no obligation to allow an individual to become an SLP district administrator based solely on a "clear" background check. Denial may be appealed via the process outlined in Procedure 197.

ANNUAL MEETING WITH KEY CLUB AND CKI ADMINISTRATORS: Each Key Club district administrator and CKI district administrator shall hold an annual meeting, either in person or virtually, with Kiwanis International staff and the district Youth Protection manager to discuss respective Key Club and CKI district events and activities and the status of the respective district Key Club and CKI programs.

TRANSPORTATION: When transporting youth, the best practice is the "rule of threes," with at least three people in the vehicle at all times, along with documented approval from a parent or guardian for the transportation arrangements. When both of these conditions cannot be met, one of them should be. All transportation decisions should be made in accordance with local laws and school policies.

USE OF ALCOHOLIC BEVERAGES, TOBACCO, MARIJUANA AND OTHER SUBSTANCES: While

attending any Kiwanis event that is produced primarily by or for the benefit of youth, adults are expected to refrain from using or being under the influence of alcoholic beverages, tobacco and/or marijuana products, even if prescribed for medicinal use. In addition, the use and/or possession of illegal drugs or the improper/illegal use of legal drugs is prohibited.

MEDICATIONS: The possession of prescription and non-prescription medications by youth at a Kiwanis event should be permitted only by the written permission of the parent/guardian.

REPORTING: If a Kiwanian observes troubling behavior involving a youth at a Kiwanis event or becomes aware of a situation that is illegal or potentially unsafe for a young person at a Kiwanis event, they must immediately contact the appropriate personnel at the event, as well as provide notification to law enforcement personnel as appropriate. All local, state, provisional and federal laws regarding reporting must be followed. If the Kiwanian becomes aware of the troubling behavior after the event, they must contact leaders of the event and provide notification to law enforcement personnel as appropriate. Kiwanis

International now offers a 24-hour, confidential helpline at 1-866-607-SAFE. The helpline can be used if you think a youth has been harmed or their safety and well-being are at risk.

personal information of any youth attending a Kiwanis event, including registration forms, medical information forms, permission to treat forms, etc., should be treated as confidential. Processes that protect this information must be created, including minimizing the number of people who have access to any such documents. The documents shall be maintained a minimum of three years or longer, as may be required by applicable state/provincial laws and regulations. After the maintenance period has expired, the documents shall be destroyed in a way that maintains confidentiality, such as shredding. The disposal and destruction of all confidential information shall conform to applicable state/provincial laws and regulations.

YOUTH AND SOCIAL MEDIA: For any social networking site that involves requesting a connection (such as inviting someone to be a friend on Facebook), adults should never initiate such connections with youth. If a youth requests such a connection from a Kiwanian, the Kiwanian should use their best judgment in responding. Adults should treat their interaction with youth on social networking sites as though the interaction were occurring in public, in front of other adults and young people. In other words, if it would not be appropriate to say something to a young person in public, it should not be said as a comment on a social networking site, either. Kiwanians should refrain from interactions that can be seen as excessive (such as constantly "liking" or commenting on a person's posts on Facebook). Prior to posting any media online, such as photographs, obtain permission from all individuals (or parents, for minors) who appear in that media; it could be illegal to do otherwise. See Kiwanis International Policy B for complete social media guidelines.

BEHAVIORAL OR HEALTH ISSUES: Kiwanians are often seen by a young person as adults to trust with personal and/or sensitive information. Kiwanians should refrain from counseling youth and should instead find, or assist the young person in finding, appropriate expert assistance.

CONFLICTS WITH OTHER RULES: Whenever these policies conflict with local school policies or rules, or local, state/provincial or national laws or regulations, the highest applicable standards for conduct shall prevail.



Hometown HEROES

Lucy Davis: nutrition to support students

t's a party-like atmosphere as a dozen or so volunteers march single file around the perimeter of a room. They laugh as they fill plastic bags with nonperishable food items.

"We have a good time," Lucy Davis of Toccoa says.

A few minutes later, the volunteers have packed 221 bags, and more volunteers arrive to transport the sacks to Stephens County schools.

Prior to her retirement in 2010, Davis worked as a nurse and high school health occupation teacher.

"After I retired, I wanted to—needed to—do something productive," the 83-year-old remembers. "And then I heard Pat Standard talking about Neighbors4Neighbors on the radio, and I decided to volunteer."

Neighbors4Neighbors is a nonprofit organization dedicated to feeding and comforting hungry individuals and families in Stephens County. It is also the sponsoring agency for Food2Kids, a program that provides weekend meals for students in the local school system who have been identified by school officials as being food-insecure.

"In my time working at the high school, I developed close relationships with my students, and I learned a lot about their problems and needs," Davis says. "Being hungry on the weekends with no food in the house is just one example."

She focused her efforts on the Food2Kids program, which originally served only local elementary schools.

"When a child moves to middle school, it doesn't change the fact that there may not be enough food at home during the weekend," she says. "So, we started providing bags for middle school and high school students, too. And we've since included the Head Start kids." (Head Start is a federal program that assists low-income families in supporting the mental, social and emotional development of children from birth to age 5.)

An army of community volunteers gathers each week to fill bags with 8 pounds of nutritious products such as stew, beans, cereal, oatmeal, crackers, granola bars, fruit cups and peanut butter, costing about \$7 (about \$275 per student per school year). Distribution of the bags is up to the schools.

Davis is moved by the outpouring of love, time, food and financial support that volunteers and members of the community have provided to help the organization carry out its mission.

"All we have to do is ask. Individuals and businesses always help us," she says. "They understand that children can't learn when they are distracted by hunger."

In October, Davis received a Lifetime Achievement Award from the Toccoa-Stephens County Chamber of Commerce, recognizing her tireless dedication to the program.

"I hope others in Georgia will step forward to help hungry kids in their hometowns," she says. "I feel really good about



what we've accomplished here. I invite others to get involved. Come join the party!"
